- As an exchange student, you are allowed to take as many ECTS as you wish/term (no minimum, no maximum), depending on your home university requirements.
- As an exchange student, you have access to all courses at the FGES, regardless the field or the academic year.

- **Lectures** (*Cours Magistraux* in French) are courses taught in amphitheaters and **Tutorials** (*Travaux Dirigés* – TD – in French) are seminars (courses taught in smaller groups).

Reading Programme – Minimum level of B2+ in oral and written English

<p>Method & Content: You will study a variety of business topics via selected articles from renowned sources such as the Economist and The Guardian which form the prescribed reading programmes the French Bachelor’s students are assessed on in their end of semester exams. You will tutor those students, accompany them in the preparation and practice of a summary and analysis of the articles as well as providing valuable feedback to help them in their final written or oral exams.</p> <p>Assessment: You will be evaluated on your level of participation in addition to a short report (6 – 10 pages) in English which is to be submitted at the end of the course. The aim of the report is to provide your feedback on the Reading Programme, what you personally learned from an intercultural perspective as well as giving a detailed evaluation of the individual students and recommendations.</p>	2



Programa de Radio (Económico, cultural) – For natives only

<p>¿A quién se dirige? : A alumnos hispanófonos que quieran preparar con uno o varios grupos un programa de radio con alumnos francófonos de la FGES en Licence Internationale 2 (Segundo curso) LI2.</p> <p>Método: Eminentemente práctico y en equipo. El alumno hispano se convierte en tutor del grupo.</p> <p>Contenido: cada grupo definirá un sujeto (económico, social o cultural) para su programa de radio, sujetos relacionados con el país de origen de cada estudiante. Ejemplos: “El turismo español y su importancia en la economía del país” “Los grandes retos de América latina ” ...etc. Es imprescindible presentar el tema y después organizar un coloquio.</p> <p>Evaluación:</p> <p>Oral: Presentación del programa de radio con los estudiantes franceses (participación en el coloquio).</p> <p>Escrito: Un informe por parte del estudiante extranjero.</p>	2

<p>Dieses Programm richtet sich auch an deutschsprachige Studierende, die mit einer oder mehreren Gruppen eine Nachrichtensendung mit französischsprachigen Studierenden der FGES in Licence International 2 (zweites Jahr) LI2 vorbereiten möchten. Die Themen basieren auf aktuellen Anlässen und können folgende Themen umfassen: Bildung, Gesundheit, Wirtschaft, Politik, Kultur, Soziales (Neue Trends am Arbeitsplatz, Die Europäische Union, Globalisierung und internationale Wirtschaft...).</p> <p>Der deutsche Student wird der Tutor der Gruppe. Ziel ist es, Input zu diesen Themen zu liefern, Texte auszuwählen, um eine Pressemappe mit verwandten Artikeln zusammenzustellen, kulturelle Referenzen und Vokabeln zu erklären und Diskussionen und Debatten mit kleinen Gruppen zu gewährleisten. Gemeinsam mit den Studierenden von LI2 legen sie die Themen für ihr Nachrichtenprogramm fest.</p> <p>Mündlich: Präsentation des Nachrichtenprogramms mit den französischen Studenten in Form eines Videos</p> <p>Schriftlich: Die Artikel sollten dem Tutor zur Validierung und Überprüfung übergeben werden. Ein kurzer Bericht, der die Auswahl der Themen begründet und der die Nachrichten auswertet, sollte ebenfalls übergeben werden.</p>	2
