

## Important notes and explanations on application

- 1. I am aware that enrolment may be denied if I have been convicted of a criminal offense by a final court decision. Such a criminal offense, which leads to the exclusion of enrolment, exists in particular in the case of violations of the Narcotics Act as well as acts in connection with the use of violence against persons or participation and support of actions against dissenters, which are associated with violence. Actions of psychological content are also considered as violence. The university decides on the existence of an obstacle to enrolment. I assure that there is no legally binding criminal judgement against me. I am not aware of any criminal investigation being conducted against me.
- 2. I am aware that my application must be received by the specified application deadlines. I have taken note of the information in the information sheet on the award procedure.
- 3. All information I have provided in connection with this application is true and correct. I am aware that false information may lead to exclusion from the award procedure or to withdrawal of enrolment.
- 4. I am aware that I will be excluded from the allocation procedure if I do not submit my university entrance qualification by the deadline specified in the information sheet (receipt by the TH Augsburg) at the latest. Likewise, I will lose an already allocated study place if I do not return the application for enrolment in time.
- 5. I am aware that during my studies, practical semesters, exercises and excursions are planned and that the respective regulations regarding participation are binding.
- 6. I acknowledge that the application documents submitted to the TH Augsburg will remain stored at the TH Augsburg and will be deleted after completion of the application process if I do not enrol.
- 7. I am aware that in addition to the student union fee, a fee for the semester ticket of the Augsburger Verkehrsverbund will be charged.
- 8. The Bavarian University Innovation Act (BayHIG), the statutes on the more detailed design of the local selection procedure at Technical University of Applied Sciences Augsburg, the statutes on the implementation and design of the aptitude tests in the undergraduate degree programs and the procedure for determining the course-related aptitude in master's degree programs at

Technical University of Applied Sciences Augsburg, the Statutes on the Procedure for Determining Suitability for Studies via a Trial Study for Qualified Professionals at Technical University of Applied Sciences Augsburg and the Statutes on the procedure for enrolment, leave of absence and exmatriculation at Technical University of Applied Sciences Augsburg in their respective current versions are taken as basis.

  (a) Bavarian Higher Education Innovation Act (BayHIG); (b) Qualification Ordinance (QualV); (c) Higher Education Framework Act (HRG); (d) State Treaty on the Allocation of Study Places; and (e) Law on the Implementation of the State Treaty on the Allocation of Study Places; (f) Higher Education Admission Act (BayHZG); g) Higher Education Admission Ordinance (HZV); h) Statutes on the detailed design of the local selection procedure at Augsburg University of Applied Sciences; i) Statutes on the procedure for enrollment, leave of absence and exmatriculation at Technical University of Applied Sciences Augsburg; j) Statutes on the implementation and design of the aptitude test in undergraduate degree programs and the procedure for determining aptitude in master's degree programs at Technical University of Applied Sciences Augsburg; k) Statutes on the procedure for determining aptitude for study via a trial study for qualified professionals at Technical University of Applied Sciences Augsburg; l) Statutes on admission figures at Technical University of Applied Sciences Augsburg in the current versions.
- 11. I declare that I have independently taken note of the general and special examination regulations relevant to my studies.
- 12. In the case of an application from the PR China, India, Vietnam and Mongolia, I agree that the university, upon request, will transmit my application data to the academic testing center of the respective country for the preparation of the APS certificate.
